ARTICLES OF ORGANIZATION OF 46th LANE COURT YARD, LLC

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

Article 1. Name. The name of the Limited Liability Company is 46th LANE COURT YARD, LLC.

Article II. <u>Address</u>. The mailing address and street address of the principal office of the Limited Liability Company is 1612 Cape Coral Parkway East, Cape Coral, FL 33904.

Article V. <u>Term.</u> The Limited Liability Company shall commence on the date these Articles of Organization are filed with the Office of the Florida Department of State and shall be perpetual, unless the Company is earlier dissolved in accordance with the provisions of the Operating Agreement or applicable law.

Article VI. Management. The Limited Liability Company will be managed by one or more Managers, whose identities and terms of office shall be set forth in the written Operating Agreement of the Limited Liability Company. The initial Managers of the Limited Liability Company are Russell A. Whitney and Michael Bartlett.

Article VII. <u>Limitation on Agency Authority of Members</u>. Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.
