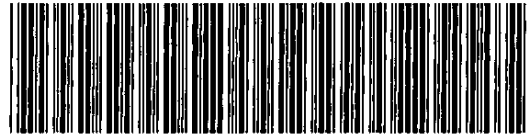

The name of this limited liability company will be Junicon Enterprises L.L.C..

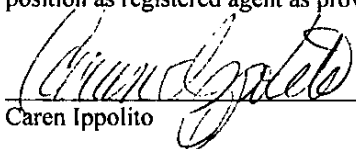

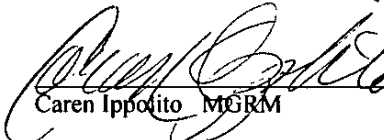
