# A Florida Limited Liability Company

## Section 1.01 Introduction and Preliminary Statements

### Section 1.10 Additional Members

The Company shall have the right to admit additional Members to the Company in accordance with the terms and conditions of the Company's Operating Agreement. # Section 1.11 Continuation of Business.
