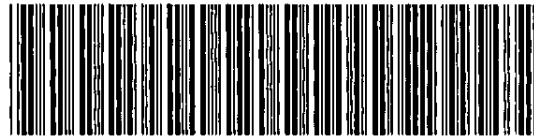

ARTICLE III: Amendment


