**ARTICLES OF ORGANIZATION
OF
JEFFREY & JAN GREENHAWT ENTERPRISES, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Jeffrey & Jan Greenhawt Enterprises, LLC (the "Company").

The duration of the Company shall be perpetual, subject to termination in accordance with the Company's Operating Agreement or by the written agreement of the members.
