ARTICLE I

ARTICLE II

TERM: The existence of the limited liability company will be perpetual.

ARTICLE VI

PURPOSE: The purposes for which the STRAWBRIDGE BUILDERS GROUP, L.L.C. is formed are:



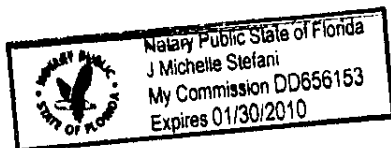


