## ARTICLES OF ORGANIZATION OF TRG of TEMPLE TERRACE, LLC

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, codified in Chapter 608, Florida Statutes, as amended, hereby form a Florida limited liability company ("Company") pursuant to the Act and hereby set forth the following Articles of Organization (these "Articles").

### ARTICLE I Name

### ARTICLE II Address of Business

#### ARTICLE IV **Commencement Date and Duration**

This Company shall commence on the date and time when the Articles are filed in the Department of State, in accordance with the provisions of Section 608.409(1), Florida Statutes, and shall continue perpetually or until dissolved in accordance with Section 608.441(1), Florida Statutes, to wit:

- by written consent of all of its members; or (a)
- upon the occurrence of one or more events specified in the operating (b) agreement; or
  - upon entry of an order of dissolution by a court of competent jurisdiction; or (c)
- at any time there are no members, unless, within 90 days after the occurrence of the event that terminated the continued membership of the last remaining member, the personal representative or other legal representative of the last remaining member agrees in writing to continue the Company, as provided in §608.441(1)(d) of the Florida Statutes.

#### ARTICLE V Purposes

This Company is created and formed for the purpose of engaging in all lawful businesses authorized for a Company pursuant to Section 608.403 of the Act in a time but not limited to the acquisition, disposition, purchase, lease, encumbrance, Thanging, marketing, promoting, improving, developing, managing, selling, buying and otherwise dealing with operating a preschool and all such other activities incidental or useful to the foregoing.

#### ARTICLE VI **Powers**

This Company shall have all of the powers and authorities set forth in Section 608.404 of the Act.

#### **ARTICLE VII Admission of Members**

### ARTICLE VIII Voting By Members

In each matter for which a vote of the members is required by the Act, consent of a majority-in-interest of members shall decide the issue, unless otherwise stated in these Articles of Organization or the Operating Agreement or the Act. However, the members' right to vote on a *dissolution* of the Company shall be governed by §608.441 of the Act, unless otherwise stated in these Articles of Organization or the Operating Agreement (i.e., unanimous written consent of members), and the members' right to vote on a *merger* of the Company shall be governed by §608.4381 of the Act, unless otherwise stated in these Articles of Organization or the Operating Agreement.

### ARTICLE IX Right of Assignee to Become a Member

An assignee of an interest in the Company may be admitted as a Member upon the consent of all other members.

### ARTICLE X Withdrawal of Member

A member shall have the right to withdraw and to demand either the return of any or all of the member's capital contribution or the value of the transferor's membership interest, as provided in the Operating Agreement. At any time that the Company owns an interest in a franchise of Goddard Systems, Inc., the transfer of a Membership Interest is restricted by the terms of Section 12 of the GODDARD SYSTEMS, INC. 2006 FRANCHISE AGREEMENT.

### ARTICLE XI Property

- (a) <u>Ownership</u>. All property originally paid or brought into, or transferred to, this Company as contributions to capital by the members, or subsequently acquired by purchase or otherwise on account of this Company shall be the property of this Company.
- (b) <u>Title</u>. The title to all property of the Company shall be held in the name of this Company.

(c) <u>Conveyances</u>. ### ARTICLE XII Amendments

These Articles, except with respect to vested rights of the members, may be amended at any time by vote by a majority-in-interest of its members. Such amendments shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411, Florida Statutes.

### ARTICLE XIII Operating Agreement

The *manager* is hereby authorized and directed to prepare and adopt an Operating Agreement for the governing of the internal affairs of the Company containing such provisions as they consider necessary, reasonable or desirable, except that no provisions of such Operating Agreement may conflict with the provisions of these Articles, unless otherwise permitted herein. The power to adopt, alter, amend or repeal the Operating Agreement shall be set forth in the Operating Agreement, except that the initial form shall be approved by the vote of a majority-in-interest of members.

### ARTICLE XIV Contracting Debts

No debt shall be contracted or liability incurred by or on behalf of this Company except by its managers, and no member is authorized or empowered to contract debts or incur liabilities on behalf of this Company unless such member is also a manager.
