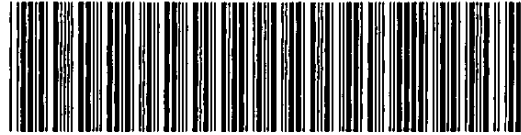

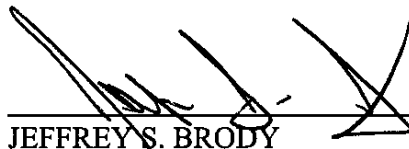
#### **ARTICLE VI AMENDMENT**
