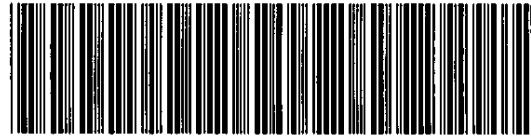

**ARTICLE VIII – Certificated Interests**


