**ARTICLES OF SECOND AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LIBERTY VP DAYTONA-LPGA, LLC
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **LIBERTY VP DAYTONA-LPGA, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

- FIRST:** The Articles of Organization were filed on June 19, 2007, and assigned document number L07000064289.
- SECOND:** Articles of Amendment to the Articles of Organization were filed on August 2007, which changed the name of the Company from Liberty VP LPGA, LLC, Liberty VP Daytona-LPGA, LLC (the "First Amendment").
- THIRD:** Article I of said Articles of Organization, as amended pursuant to the terms of the First Amendment, is hereby amended in its entirety to change the name of the Company from "LIBERTY VP DAYTONA-LPGA, LLC" to "LIBERTY VP BRADENTON, LLC", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I - NAME"

The name of this limited liability company is **LIBERTY VP BRADENTON, LLC** (the "Company").

- THIRD:** All other provisions of the Articles of Organization, as amended pursuant to the terms of the First Amendment, remain unchanged and in full force and effect.
- FOURTH:** The foregoing second amendment was adopted by the sole Member of the Company pursuant to approval and execution of that certain Written Consent of Sole Member of even date herewith.
