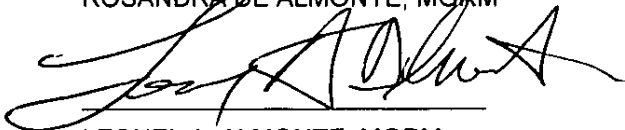
1. The name of the limited liability company is: ASR Cellular, LLC
