ARTICLES OF ORGANIZATION
OF
WRIGHTWAY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Wrightway, LLC (the "Company").

ARTICLE II

PURPOSES AND POWERS


ARTICLE VI**MANAGER**
