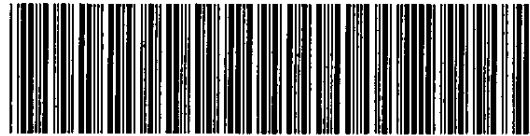

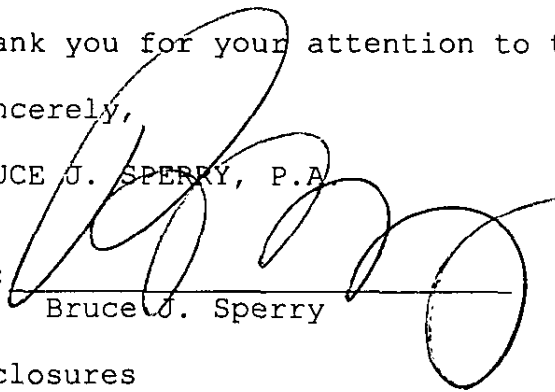

AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF
SMH, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Amended and Restated Articles of Organization. The original Articles were filed June 20, 2007, and the name of the Company remains the same and unchanged.

ARTICLE I
NAME

The name of the Limited Liability Company shall be SMH, LLC ("Company"). The principal place of business of the Company in Florida shall be 965 Candlelight Boulevard, Brooksville, Florida 34601, and the mailing address shall be 965 Candlelight Boulevard, Brooksville, Florida 34601.

ARTICLE II
DURATION

The Company commenced its existence on June 20, 2007, the date the Articles of Organization were filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Amended and Restated Articles of Organization and the Company's regulations.

ARTICLE III
PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a Limited Liability Company under the laws of the State of Florida.

ARTICLE IV
REGISTERED AGENT

The name and street address of the registered agent of the Company in the State of Florida is Harshadbhai Patel and the initial registered agent's office is located at 965 Candlelight Boulevard, Brooksville, Florida 34601.

ARTICLE V
CAPITAL CONTRIBUTIONS

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be

amended from time to time in accordance with its terms.

ARTICLE VI
ADMISSION OF NEW MEMBERS (TRANSFERABILITY OF INTERESTS)

No additional members shall be admitted to the Company except with the unanimous written consent of all the equity members of the Company and upon such terms and conditions as shall be determined by all the equity members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous written consent.

ARTICLE VII
MEMBERS RIGHT TO CONTINUE BUSINESS

The Company shall not be dissolved upon the death, retirement, resignation, insanity, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member of the Company, provided there is at least one (1) remaining member, unless terminated in accordance with regulations adopted by the members.

ARTICLE VIII
MANAGEMENT BY MEMBER(S)

The overall management of the Company shall be vested in its members, as provided by these Amended and Restated Articles of Organization and Section 608.407 of the Act. Any and all action by the Company, except as otherwise provided in the Operating Agreement, shall require the vote of the members holding a supermajority interest of seventy-five percent (75%) interest in the Company. The initial members of the Company are:
