ARTICLES OF ORGANIZATION

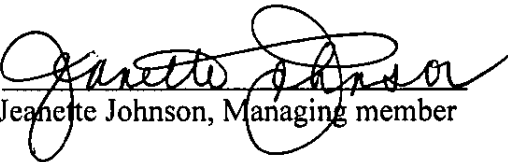

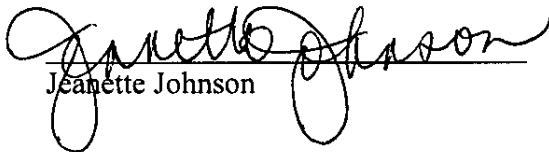
