

1. He is the current Manager and Secretary of PROPERTIES NO INK LLC, a Florida limited liability company, whose Articles of Organization were filed with the Department of State, State of Florida, on June 21, 2007.


membership of a member, the remaining members shall continue the business operations of this Limited Liability Company.
