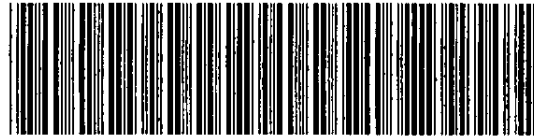

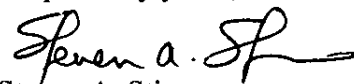

**ARTICLES OF ORGANIZATION
OF
STINSON FORENSIC INSURANCE CONSULTING, L.L.C.**

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act") for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name:

The name of the limited liability company is STINSON FORENSIC INSURANCE CONSULTING, L.L.C. (hereinafter referred to as the "Company.")

2. Period of Duration:

Unless terminated under the Act or by a unanimous vote of the member(s), the period of duration of the Company shall be perpetual.

3. Purpose:

The purpose for which the company is organized is to engage in forensic insurance consulting before, during, and after trial and such other forensic consulting for which the member(s) or its employees are qualified, and any and all other business and activities permitted by the Act or any other applicable laws of the State of Florida. 6. Manager or Managing Members:

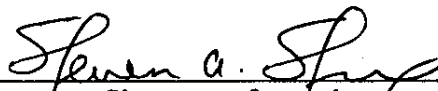
