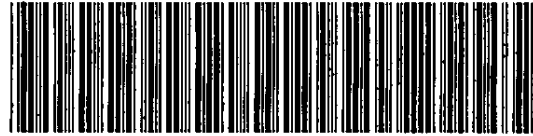

## ARTICLES OF ORGANIZATION

of
