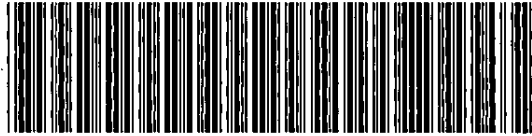

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: FRANKENBURGER FARMS, LLC.

ARTICLE II -- ADDRESS

The street address of the principal office for this company is 1420 Eighty Foot Road, Bartow, Florida 33830, and the mailing address is 1420 Eighty Foot Road, Bartow, Florida 33830.

ARTICLE III -- DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date, if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- ADMISSION OF NEW MEMBERS



ARTICLE VII -- RESIDENT AGENT ACCEPTANCE

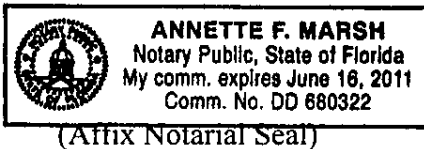




