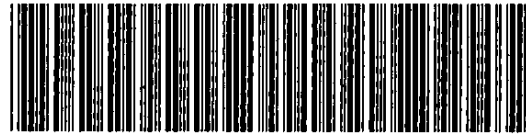

NAME**




