ARTICLE III

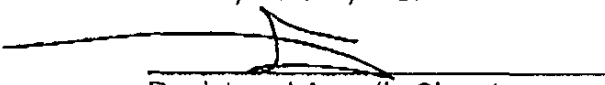
The purpose for which this limited liability company is organized is to engage in any activity or business permitted under the laws of the United States of Florida.

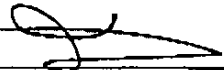
