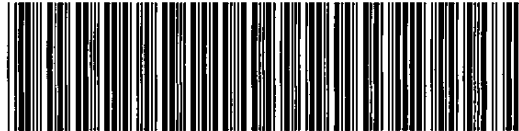

**ARTICLE I.
NAME**

The name of the Limited Liability Company is *VISION SALES 2008, LLC* (the "Company").

**ARTICLE II.

DURATION**

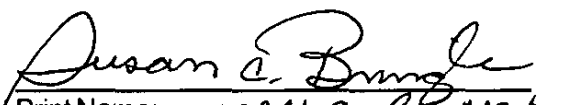
