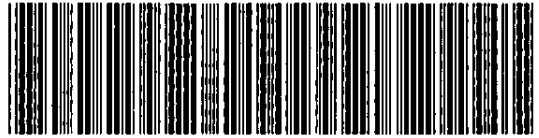



THIRD: The Company is hereby dissolved upon request and written consent of all members of the LLC.


FOURTH: All debts, obligations, and liabilities of the LLC have been paid or discharged.
