#### ARTICLE V MERGER

- A. <u>Transfer of Assets and Liabilities</u>. The merger shall be effectuated by ALLIANCE LINEN SERVICE, LLC transferring all its assets and liabilities to ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC. Upon the transfer of said assets and liabilities, ALLIANCE LINEN SERVICE, LLC shall automatically cease and will no longer exist as an independent limited liability company.
- B. <u>Converting Memberships</u>. The membership of ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC and ALLIANCE LINEN SERVICES, LLC are identical prior to the merger transaction, with each of the three members of both entities owning 33.33% of equity. It is the intent of the members of each merging entity that all of their incidents of ownership in the surviving entity, ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC, will equal each member's pre-merger ownership in each of the separate entities being merged. Consequently, the three members of each of ALLIANCE LINEN SERVICE, LLC and ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC will each own 33.33% of the survivor of the merger, ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC, which will own 100% of all of the assets and liabilities of both parties to the merger. As of the Effective Date, all members of ALLIANCE LINEN SERVICE, LLC shall automatically become members of ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC with the ability to immediately receive all the rights, privileges, abilities, and benefits granted to members of ALLIANCE REAL PROPERTY HOLDING COMPANY, LLC.
- C. <u>Approval of Merger</u>. All the members of each limited liability company have approved the merger, as evidenced by their signatures affixed hereto. The merger is considered approved by each limited liability company's membership as required by Florida Statutes Section 608.4382.
