The undersigned, acting as an authorized representative of the member of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for M Track, LLC, a Florida limited liability company (the "Company").

**ARTICLE I.
Name**

The name of the Company is M Track, LLC, a Florida limited liability company (the "Company").

**ARTICLE II.
Mailing and Street Address**

The mailing and street address of the Company's principal place of business shall be 2101 South Congress Avenue, Delray Beach, Florida 33445, County of Palm Beach, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

**ARTICLE III.
Principal Office**

**ARTICLE IV.
Duration**

The Company shall exist from the date of filing these Articles with the Florida Department of State, or the later occurrence of any of the termination events specified in Florida Statute §608.441, or as may be provided in the Operating Agreement adopted by the Members, and its existence shall otherwise be perpetual.

Registered Agent and Office

ARTICLE VIII.
Termination of Membership

If a member of the Company dies, retires, resigns, is terminated, its entity is dissolved, experiences bankruptcy or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the successor member may continue the business of the Company.

ARTICLE IX.
Indemnification

To the maximum extent permitted by law, the Company shall indemnify any person who was or is a party to any proceeding by reason of the fact that he/she is or was a manager, managing member or officer of the Company or is or was serving at the request of the Company as a manager, managing member, director or officer of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in a manner he/she reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her



The Company shall reimburse each person for all costs and expenses, including, without limitation, attorneys' fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
