(b) to engage in any activities or business permitted under the laws of the State of Florida.

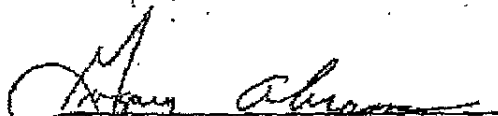
