ARTICLES OF ORGANIZATION OF PRINCE DUPLEXES II, L.L.C. A Limited Liability Company

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be PRINCE DUPLEXES II, L.L.C.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 23210 Robbins Road, Astatula, Florida 34705.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified.
