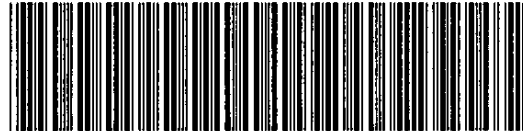

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**Article I - Name**

The name of the limited liability company shall be **TREBSON LLC** ("Company").

**Article II - Principal Place of Business and Address**

**Article VI - Management**

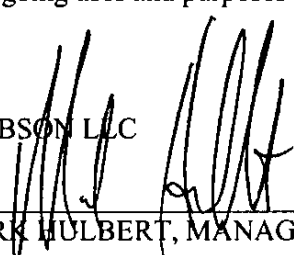

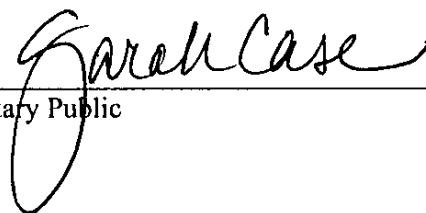

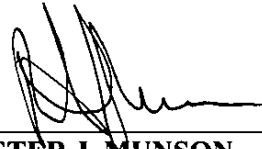
