**SECOND ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
BOOKT LLC  
(a Florida limited liability company)**

The Articles of Organization of BOOKT LLC (the "Company") were filed on June 27, 2007 and assigned Florida document number L13000065979. The Articles of Organization were amended by Articles of Amendment to the Articles of Organization of the Company filed June 11, 2008.

This amendment is submitted to amend and restate Article VI of the Articles of Organization in its entirety as follows:

**"ARTICLE VI**

There shall be eleven million two hundred fifty thousand (11,250,000) authorized units of membership interests in the Company consisting of Class A (voting) Units and Class B (non-voting) Units as follows:

No. of Units	Type of Units
10,250,000	Class A (voting) Units
1,000,000	Class B (non-voting) Units

Holders of Class A (voting) Units shall have the same rights and preferences as the holders of Class B (non-voting) Units, except that the holders of the Class B (non-voting) Units shall have no voting rights whatsoever."

Except as set forth above, the Articles of Organization of the Company shall remain unchanged.

These Articles of Amendment are hereby executed by the undersigned Manager as of the date set forth below.
