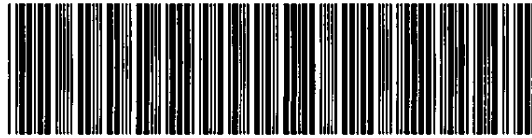



Name


The name of the limited liability company is West Wind of Barefoot Beach, LLC (the "Company").


