PLAN OF CONVERSION FOR CONTECH CONSTRUCTION, CORP.

The following Plan of Conversion is submitted in compliance with Florida Statutes section 608.439:

ARTICLE I. CONVERTING CORPORATION

The name of the Converting Corporation is Con'Tech Construction, Corp. It was first organized on March 16, 1993, as a corporation under the laws of the State of Florida.
