# ARTICLES OF ORGANIZATION OF HUNTER'S MEADOW, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. 7 Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I - NAME
