**ARTICLE VII - LEGAL ACTIONS**

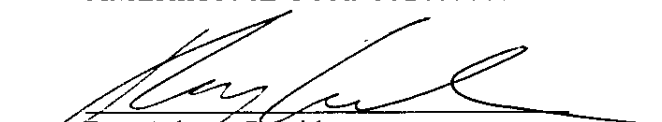
