## Articles of Organization of RLF CONSTRUCTION, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida, Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be RLF CONSTRUCTION, LLC ("Company").
