The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization.

<u>ARTICLE I</u>

The name of this limited liability company is KIANA PROPERTIES, LLC with its principal office located at 585 Commonwealth Blvd., Port Orange, Florida, 32127.

ARTICLE II

This company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

- (h). To make distribution for the public welfare or for other charitable, scientific or educational purposes.

- (j). To be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise.
- (k). To have, exercise and enjoy all of the rights and privileges of limited liability companies for profit as conferred by the laws of the State of Florida, it being expressly provided that the enumeration of the specific powers and purposes shall not be held to limit or restrict in any manner the general powers of the company.
