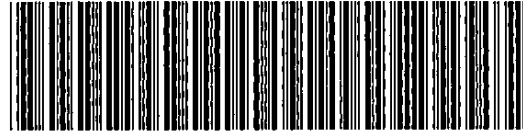

As discussed, we do not have an active registration for an entity known as CBM INVESTMENTS. Therefore, we suggested that you may wish to make the individual -- CANDACE B. MORRISON -- the R.A.

Also, as discussed, a new LLC law went into effect on July 1. The old law, which was still in effect on Friday, June 29, when this document was received did not authorize us to check LLC names, and allowed Florida LLC's to use the suffix "L.C."

Under the new law the name E. & C. LIMITED COMPANY would not be available, and the suffix "LIMITED COMPANY" would not be allowed.

The company may wish to change its name -- although the Division of Corporations has no authority to compel it to do so.
