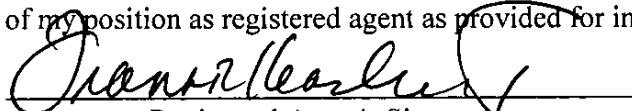

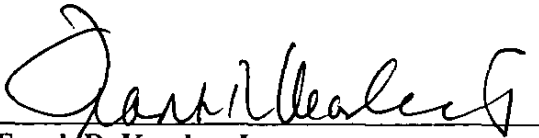
The limited liability company is a manager-managed company.
