# ARTICLES OF ORGANIZATION OF EVERGLADES SWEEPING AND GRADING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE ! -- NAME

The name of the limited liability company shall be EVERGLADES SWEEPING AND GRADING, LLC (the "Company").

# ARTICLE II -- ADDRESS

The mailing address and street address of the initial principal office of the Company shall be 9624 Whitehall Street, Naples, Florida 34109.

# ARTICLE III -- DURATION

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company's earlier dissolved as provided in these articles of organization or in the Company's operating agreement.

# ARTICLE IV -- REGISTERED OFFICE AND AGENT

A member of the Company may withdraw from the Company only upon the ununimous prior written consent of all the nonwithdrawing members of the Company.

The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.
