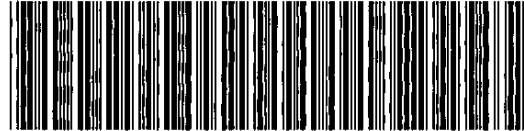


ARTICLE VI
