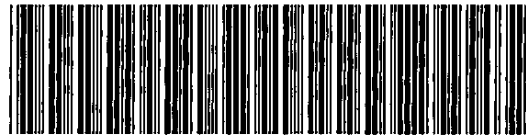

THE UNDERSIGNED, pursuant to the provisions of chapter 608 of the Florida Statutes, hereby certifies that the persons named herein have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, writes, privileges and immunities of limited liability companies for profit. It is further declared that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company shall be **HighTouch Resorts, L.L.C.**

**ARTICLE II
PURPOSE**

The purpose of this limited liability company will be to offer the very best resort service that can be provided in and around Destin, Seagrove, Okaloosa Island, and Navarre Florida, and in those counties, and in such other places as the Directors may determine to be in the companies best interest. The company may own land, lease property to or from others, may purchase real and personal property, may do business in every other way necessary to accomplish its functions, and is specifically authorized to do all things not prohibited by the laws of the United States and the State in which it does business.

**ARTICLE III
DURATION**

The period of duration for this limited liability company shall be perpetual or until dissolved in the manner provided by law, or as provided in the Regulations of this company. In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates continual membership of a member in the company, the company shall be dissolved unless the remaining members, by a majority vote, elect to continue the business of the company.

**ARTICLE IV
COMPANY ADDRESS;

The mailing address and street address of the principal office of this limited liability company is 4041 Indian Bayou N, Destin, Florida 32541. The name of its initial registered agent at such address is Stephen R. Sametz.

ARTICLE V RESTRICTIONS ON MEMBERSHIP

The members shall have the right to admit new members in such a manner set forth in the Regulations. Contributions required of new members shall be determined by the then current members as of the time of admission of new members to the limited liability company.

A member's interest in the limited liability company may be sold or otherwise transferred only as provided for in the Regulations and only after compliance with the right of first refusal contained in the Regulations. In the event an assignment or transfer is not approved by the unanimous written consent of the non-transferring members, the assignee or transferee of any such membership interest shall have no right to participate in the management of the business and affairs of the company nor to become a member therein. In such event, the assignee or transferee shall be entitled to receive only the share profits or other compensation by way of income and return of contributions to which the transferring member would otherwise be entitled.

ARTICLE VI MANAGEMENT

Management of this limited liability company shall be vested in its members whose names and addresses are as follows:

Stephen R. Sametz, has been designated as the MANAGING MEMBER with the authority to exercise all powers typically exercised by the President of a business corporation including the specific power to appoint such other officers of this limited liability company as said Managing Member deems appropriate. The initial term of the Managing Member shall be perpetual. No debt may be contracted nor contractual liability incurred by or on behalf of the company by any member other than the Managing Member.

ARTICLE VII
LIMITED LIABILITY COMPANY REGULATIONS

The power to adopt, alter, amended or repeal the Regulations governing this limited liability company shall be vested in its members.



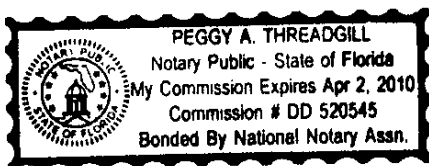
