ARTICLES OF ORGANIZATION
OF
COUNTRY OAKS OF OCALA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge and file these Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be **COUNTRY OAKS OF OCALA, LLC** ("Company").

ARTICLE II - ADDRESS

The mailing address of the principal office shall be **905 S.E. 12th Street, Ocala, Florida 34471.**

ARTICLE III - DURATION

Each member shall make additional capital contributions to the Company as set forth in the Operating Agreement.

ARTICLE VII - MANAGEMENT

Company shall be managed by its member/manager in accordance with the terms and conditions of the Operating Agreement. The Operating Agreement may contain other provisions for the regulation and management of the affairs of the Company not inconsistent with law or these

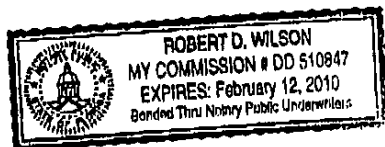
