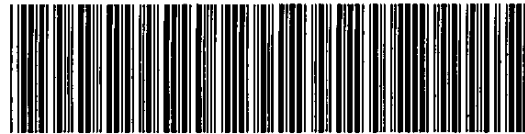

**ARTICLES OF ORGANIZATION
OF
A DAN THOMPSON HANDYMAN & LAWN SERVICE, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is A Dan Thompson Handyman & Lawn Service, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The effective date of the Company shall be July 6, 2007. The Company shall terminate on July 6, 2106.


