The undersigned, being the sole member of FGTA, LLC (the "**Company**"), for the purposes of organizing a limited liability company pursuant to the Florida Limited Liability Company Act, delivers these Articles of Organization to the Florida Department of State for filing, and states as follows:

1. **Name.** The name of the Company is "FGTA, LLC".
2. **Principal Place of Business.** The mailing address and street address of the principal office of the Company is 100 International Golf Drive, Daytona Beach, Florida 32124.
3. **Registered Office and Agent.** The name and street address of the Company's initial registered agent for service of process in Florida are Corporation Service Company, 1201 Hays Street, Tallahassee, Florida 32301.
4. **Management.** The Company shall be member-managed.
5. **Members.** The Company's sole member shall be the Ladies Professional Golf Association, an Ohio nonprofit corporation (the "**Member**").
6. **Purposes.** The Company is organized and shall be operated for the support and benefit the Member and the Member's exempt functions and purposes. Without limiting the generality of the foregoing, the Company is organized and shall be operated to establish and maintain high standards in the promotion, development and conduct of women's professional golf activities; to provide vocational opportunities in teaching, tournament play, merchandise and golf promotion for women golf professionals; to cooperate with organizations engaged in golf promotion whose objectives are compatible with those of the Member; and to protect and further the mutual interests of the Company and the Member; and thereby to promote world-wide interest in the game of golf.

In witness whereof, the Member causes these Articles of Organization to be executed by an authorized officer, as of this 6th day of July, 2007, such officer's signature constituting an affirmation under penalties of perjury that the facts stated herein are true and correct.
