Dissolution of The Pastry Lounge Cafe LLC. must occur as required by Fl. Statue 608.441 as there are no members and by the LLC's Operating Agreement due to events specified herein.

- 1) This decision is done by mutual consent of both forming members as allowed in the LLC's Operating Agreement.
- 2) Each member has personally filled for Bankruptcy and as such can no longer remain a member of the LLC placing the LLC without any members.
- 3) The LLC became insolvent prior to dissolution. The LLC was unable to provide sufficient ongoing compensation to it's members, unable to conduct daily business and unable to manage to regularly pay it's debts.

Assumption of business with rental lease and a beer and wine license and all property assets FFE located at place of business was offered to former business owner and LLC creditor. This creditor declined in writing releasing sale of assets stating he considered loan to be a personal loan and LLC members could do as they needed with business.

Some assets were sold in order to be released from lease and satisfy other debts that would then allow for the continuation and relocation of business. An attempt was made to relocate nearby but after several months a Certificate of Occupancy could not be obtained at new location. Due to lack of daily business personal debts grew including debt to above mentioned creditor. Attempts to resolve debt including offer to settle were declined and creditor filed suite both personally against members and the LLC. Neither member singularly or combined nor the LLC has assets to cover debts. Counsultation with attorney confirmed that business is insolvent and must be dissolved and members should file for bankruptcy.

All regular monthly operational debts incurred by the business were satisfied and up to date prior to dissolution aside from personal loans and line of credit.

The LLC. being insolvent and having insufficient assets distributed remaining assets per the Operating Agreement.
