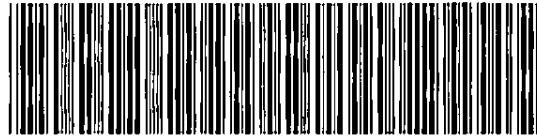

**SECOND AMENDED AND RESTATED ARTICLES OF ORGANIZATION
FOR
SILVER SPRINGS RV PARK, LLC,
A FLORIDA LIMITED LIABILITY COMPANY**

The Articles of Organization for Silver Springs RV Park, LLC were originally filed on July 10, 2007 and assigned document number L07000071712. Amended and Restated Articles were filed on August 10, 2007. These Second Amended and Restated Articles of Organization are being filed in accordance with Section 605.0202 of the Florida Statutes, shall be effective as of their date of filing and shall amend and replace, in their entirety, all previously filed Articles of Organization and any and all amendments thereto.

ARTICLE I – NAME

The name of the limited liability company shall be Silver Springs RV Park, LLC ("Company").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the company shall be c/o Wolfson & Associates, 2801 N. University Drive, Suite 306, Coral Springs, FL 33065.

ARTICLE III – PURPOSE

A. Specific Purpose. The purpose of the Company shall be to acquire, operate, manage, maintain and dispose of commercial real property, including but not limited to, mobile home parks and recreational vehicle parks.

B. Indemnification. Notwithstanding any provision hereof or of any other document governing the formation, management or operation of the Limited Liability Company to the contrary, the following shall govern: Any indemnification shall be fully subordinated to any obligations respecting the Property and shall not constitute a claim

against the Limited Liability Company in the event that cash flow is insufficient to pay such obligations.

ARTICLE IV - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

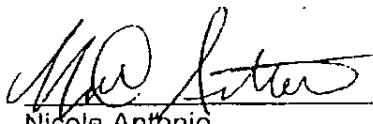
