## ARTICLES OF ORGANIZATION OF BBC INVESTMENT GROUP, LLC, a Florida Limited Liability Company

TALLAHASSEE TOO

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

## ARTICLE I

The name of the limited liability company is **BBC INVESTMENT GROUP, LLC**, a Florida limited liability company (the "Company").

## ARTICLE II PRINCIPAL PLACE OF BUSINESS
