The mailing address and principal place of business of the Company is 333 3rd Avenue North, Suite 400, St. Petersburg, Florida 33701.

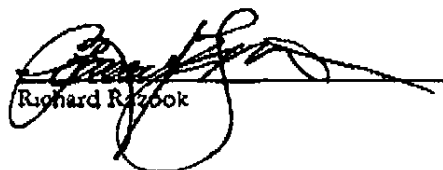
**ARTICLE III

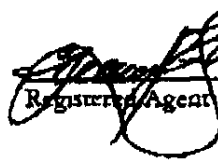
