DURATION**

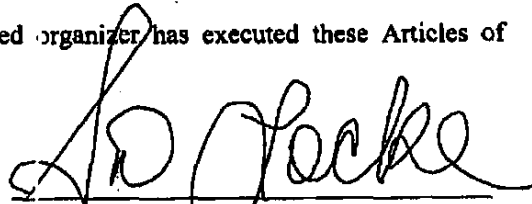
The Company's existence shall commence as of July 11, 2007 and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement.

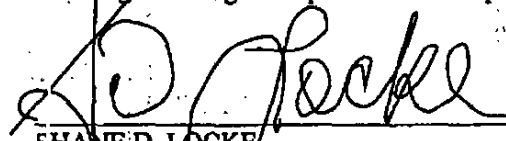
