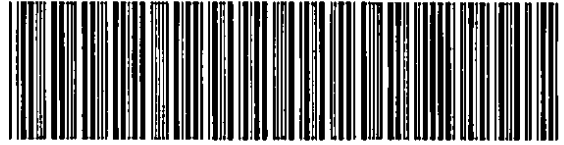

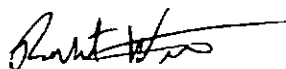

**AGREEMENT AND ASSIGNMENT
OF MEMBERSHIP INTEREST

3. Robert Wiest and Susan Wiest as members of the LLC do consent to the foregoing assignment.

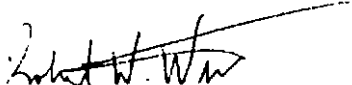

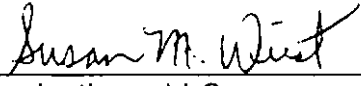
