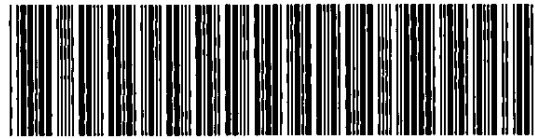

The name of the Limited Liability Company is CF FINANCIAL SERVICES, LLC (the "Company").


ARTICLE II - Address


