**ARTICLES OF ORGANIZATION
OF
KREYSAIR, LLC**

ARTICLE I: NAME

The name of this limited liability company is **KREYSAIR, LLC** (hereinafter "Company"), whose mailing address and street address of the principal office of the limited liability company is **2418 Laguna Drive, Fort Lauderdale, Florida 33316**.

ARTICLE II: DURATION

This limited liability company shall remain in existence perpetually; and the effective date of commencement is hereby designated as **the date of filing of these Articles**.

ARTICLE III: PURPOSE

This limited liability company is organized to transact any lawful business for limited liability companies organized under Chapter 608 of the Florida Statutes "Limited Liability Companies", including purchasing or otherwise acquiring, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of every class, kind and description; and to carry on any business which can be advantageously pursued in conjunction with or incidental to any of the above purposes.

ARTICLE IV: COMPANY MANAGEMENT

The Company is a manager-managed company. The management of the Company is reserved to Adam G. Kreysar as the Manager/Member, regarding all actions and business of the Company;

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this limited liability company is **2418 Laguna Drive, Fort Lauderdale, Florida 33316**, and the name of the initial registered agent of this limited company is **Adam G. Kreysar**.

ARTICLE VI: MEMBERS

The names and addresses of each member of this organization are: Adam G. Kreysar and Tina R. Kreysar, husband and wife, as joint tenants by the entirety, 2418 Laguna Drive, Fort Lauderdale, Florida 33316; and the ownership of each member is as follows:

ARTICLES VII: TRANSFER OF OWNERSHIP

The ownership interest of any member may not be transferred to a non-member except as set forth in the Operating Agreement of the Company. In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member, this limited liability company may continue to operate, providing: (i) a surviving member remains as an owner of the Company; or (ii) a sole member's interest is immediately transferred to a successor in interest; or (iii) upon the written consent of all remaining, if

any, members in this limited liability company.


ARTICLE VIII: ADDITIONAL MEMBERS

Additional members may be added with the consent and written amendment executed by all (100%) of the members.

ARTICLE IX: AMENDMENT

This limited liability company reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment thereto, and any right conferred upon the members is subject to this reservation.


